

In consideration of being able to participate in any cycling ride or event that is promoted, organised or conducted by Bike 50 Cycling (the Group), I agree to be bound by these Terms and Conditions.

1. Preliminary

- I have read and understood the Safety page as displayed on the Bike50 web site.
- I will ride in a safe and responsible manner at all times.
- I am aware that the Group strongly advises me to wear a cycling helmet that meets U.K. standards at all times (also refer to section 2.5).
- I will comply with all reasonable directions given to me by a representative of the Group.

2. Assumption of Risk (Risk Warning)

- 2.1 I acknowledge that cycling (either on roads or mountain bike tracks) can be a dangerous recreational activity and involves obvious and inherent risk. The risks associated with participating in a ride or event includes but is not limited to the following:
 - cycling in difficult conditions; the physical exertion for which I may not be prepared;
 - riding in poor weather conditions;
 - riding in a bunch with persons of varying degrees of skill; riding on poor quality road or track surfaces;
 - riding on tracks that are narrow, steep, slippery and challenging;
 - riding on congested public roads;
 - colliding with another cyclist; or colliding with another user of the road or track.
- 2.2 I am aware of the risks referred to in clause 2.1 and I also acknowledge that cycling accidents causing death, bodily injury, disability, property damage and economic loss can and do happen.
- 2.3 I acknowledge that my participation in a ride or event or is at my own risk.
- 2.4 I am responsible for ensuring that: I have adequately and appropriately prepared both physically and mentally; and my bike is in sound mechanical order before participating in a ride or event.
- 2.5 If I decide not to wear a crash helmet then I accept that I am at a greater chance of injury at my own risk.

3. Exclusion of Liability

To the maximum extent permitted by law, under no circumstances will the Group, its officials, servants, representatives, agents and sponsors (or any of their respective representatives), be liable for my death, personal injury, loss or damage (including loss or damage to property) in any way caused, which may be sustained or incurred by me as a result of participating in an event or ride.

4. Release

With effect on and from the date of these Terms and Conditions, I release and discharge the Group, its officials, servants, representatives, agents and sponsors (and any of their respective representatives), from all claims and liabilities of any nature that I may suffer or incur arising from or in connection with or incidental to my participation in a ride or event.

5. Indemnity

I indemnify the Group, its officials, servants, representatives, agents and sponsors (and any of their respective representatives), against any claim, loss, damage, liability, cost and expense that may be incurred or sustained by the Group, its officials, servants, representatives, agents and sponsors (and any of their respective representatives), caused by or arising out of any act, matter or thing done, permitted or omitted to be done by me in a ride or event.

6. Other

- 6.1 The Group reserves the right, in its absolute discretion, to refuse an application for membership, or a renewal of membership.
- 6.2 These Terms and Conditions contain the entire agreement between the parties with respect to its subject matter. It sets out the only conduct relied on by the parties and supersedes all earlier conduct and prior agreements and understandings between the parties in connection with its subject matter.
- 6.3 These Terms and Conditions are governed by the laws of the United Kingdom. Each party submits to the jurisdiction of courts exercising jurisdiction there, and waives any right to claim that those courts are an inconvenient forum.
